Subcontract Duration: 18 months

Objective:

• Combining with GEF project funds, incandescent manufacturer utilizes its own inputs to carry out the conversion project to energy efficient lighting products.

Qualifications:

- One of the manufacture from the recommended short name list for pilots program provided by the subcontractor of "Planning of IL manufactures' business conversion" (China Association of Lighting Industry);
- Ensure adequate funding, resources and manpower to fulfill the goals of conversion pilot project.

Main tasks:

- Assisting "Planning of IL manufactures' business conversion" sub-contract unit (China Association of Lighting Industry) develop specific implementation plan and time schedule of incandescent manufacturers' conversion;
- Organize and implement the business conversion according to the defined plan. Automated production lines should be introduced. The level of the transitioned production technology and production equipment should reach the advanced level of the lighting industry, and the product quality & performance indicators should satisfy the national standard. At the end of sub-contract, the reduced amount of incandescent lamps should not be less than 20% of its total output, and new energy efficient lighting products should not be less than 10% of its reduced IL output;
- Under the guidance of "Planning of IL manufactures' business conversion" sub-contract unit, record and summarize the implementation progress, energy conservation and co-financing funds for IL conversion, analyze the obstacles and propose solutions in transition;
